The operating budget of the Village of Northfield is \$13.2 million. The Village Hall is located at 361 Happ Road and the Village's Fire-Rescue and Public Works facility is at 1800 Winnetka Road in Northfield, Illinois. The Village also has a pumping station for its water distribution system located on Willow Road. The Village currently employs approximately 48 full and 63 part-time employees.
