#### **Approve Summary Notes of the August 26, 2009 Meeting**

A motion was made by Member Moore and seconded by Member Fischer to approve the August 26, 2009 Summary Notes. By voice vote all approved.

#### **Update on Willow Road and Final Approval of Community Advisory Group List**

Chair Hayward distributed the list to all the Community Advisory Group (CAG) members and explained that it was also being sent to IDOT to meet their Friday deadline. Several Committee members asked about people they had suggested and why they were not included on the list sent to IDOT. Chair Hayward explained that many of the people suggested did not have the time or desire to participate at this time or there were too many duplicates under a specific category. They wanted to put forth a list that had people representing each group. Chair Hayward suggested adding a couple of new names: Chris Richards representing the Northfield Running and Cycling Club, Melissa Bianucci with the Willow Park Soccer Clubs and Anne Peterson representing a Walkable Communities Group. With those changes, the Traffic and Transportation Committee concurred with the recommended CAG list and indicated that it should be presented to IDOT.

#### **Campaign Funding Update**

Chair Hayward noted that the school Board is in its final stages prior to a recommendation relative to assisting with funding. He expected the T&T Committee would hear from them in early October. There has been no news or change with the Park District Board or NSAG. The NSAG group was waiting to hear what happens with the School Board; however, NSAG has started meeting again and will be working on educating the community on the upcoming

process. Chair Hayward asked staff to make sure that key information is available on the Village's website and asked for information on IDOT's website. Manager Sigman indicated that IDOT's website which is [www.willowroadfuture.org](http://www.willowroadfuture.org) is up and running and residents can track of what is happening with CAG through their site. Staff was asked to make sure that IDOT's website is linked to the Village website.
