



2020 Northfield Art Contest

The Village is partnering with the Northfield Park District on a new and exciting art contest! Anyone who lives, works, or attends school in Northfield is encouraged to submit their two-dimensional art that answers the question, "Why do you love Northfield?" Artwork can be any artistic medium (photography, paint, crayon, etc.). The original artwork does not need to be submitted, only a high-resolution .jpeg must be submitted electronically.

Artwork can be submitted January 1-February 27 and will be displayed in the Village Hall Art Gallery March 1 through April 30. The public will be invited to vote for their favorite, and the winning piece will be announced May 1. The winning image will be celebrated at the Northfield Park District's Market and Music program all summer!



2020 Art Contest Rules and Details

Requirements for Entry:

1. Artists can be amateur or professional and must be Northfield residents, work at a business in Northfield, or attend a school in Northfield.
2. A fully completed entry form and release form (if necessary) must be attached to each submission. Incomplete entry forms will disqualify the artwork from entry. Please fill out the entry form completely.
3. If there are identifiable people in a photograph taken in a non-public space or if the photograph includes a minor, you must secure a model release from the subject or, in the case of a minor, the subject's parent/guardian. A release form is included in this packet.
4. No changes will be made to entries after the due date of February 27, 2020.
5. Images should be suitable for the general public. Contest sponsors reserve the right to remove objectionable images.
6. Artwork must be original and created by the artist making the submission. Copying someone else's artwork will disqualify the entry.
7. Only one entry per artist.
8. The original artwork does not need to be submitted, only a high-resolution .jpeg must be submitted electronically.
9. By entering the contest, entrants grant the Village of Northfield and the Northfield Park District a royalty-free, perpetual, non-exclusive license to display, distribute, reproduce, and create derivative works of the entries, in whole or in part, in any media now existing or subsequently developed, for any educational, promotional, publicity, and other Village of Northfield or Northfield Park District purposes. The Village of Northfield and Northfield Park District will not be required to pay any additional consideration or seek any additional approval in connection with such uses.

Contest Timeline:

January 1-February 27, 2020: Entry forms & artwork can be submitted to mdefeo@northfieldil.org

March 1-April 30, 2020: Artwork will be displayed and the community can view and vote for their favorite. Individuals can vote only once.

May 1, 2020: The winning contest entry will be announced.
